Landscape-Mark Miskulin reported there was not much to report for this meeting. Arborist Update: Dale Caron reported that he went out at contract signing with Signature for the tree irrigation upgrades. He wanted to make sure they understood the highest priority work because they started on the riparian walkway but the pines on Calle De Oro were in the most severe need. Those trees are still not done. They are doing the work but not in the areas he requested be done the soonest. Mark asked approximately how many trees are in dire need. Dale stated probably about 6 that would take about an hour to correct. Mark Miskulin stated the committee will follow up with Signature to make that a priority.

ARC- There were 33 requests approved since the prior meeting **Compliance-** 125 yard care, 30 recreational vehicles, 60 trash cans and 5 other misc. violation notices sent since the last quarterly meeting.

After a review of cost, service and the actual background and experience the committee felt the choices should be narrowed down to two. Signature or All Seasons. If the Board decides to stay with Signature, it should only be for a one year term with dates of service defined and discounts given if the work is not done as promised. There were pros/cons of changing the All seasons that were summarized as well. There was an extended discussion about the pro/cons and contract terms. It was agreed to make the final decision in January as there was still time before a decision needed to be made.
